Code of Conduct for USY/Kadima/Pre-Kadima (Bolded part applies specifically to USY)

In connection with any chapter/regional program (including dances), including travel to and from such programs: There is to be no smoking. There is to be no possession or use of any narcotics, marijuana, other illegal drugs or prescription drugs not prescribed for the user. There will be no possession or consumption of any alcoholic beverages. There will be no shoplifting or any other theft of any kind or other activity contrary to law. If a USY/Kadima/Pre-Kadima member is caught in possession of/using alcohol or illegal drugs, he/she will immediately be sent home at his/her parents' expense. **Furthermore, USY International policy states: "Anyone violating any such rules at a regional event for the infraction of these rules is barred from International events for one year following the infraction. These events include (but are not limited to) the International USY Convention and USY summer programs."** **The Region reserves the right to impose additional sanctions in connection with this or any other improper behavior as it sees fit.** All Convention delegates are expected to be in sessions (services, meals, study groups, etc.) Each participant is expected to maintain proper decorum and attitude during the entire program. Disruptive behavior (including, among other things, inappropriate sexual behavior) will not be tolerated. Your parents will be responsible to pay for any damage you may cause. No attendee may leave the facility except at those times specified by the schedule. No attendees may leave the program venue except at those times specified by the event/program schedule. At conventions all USY/Kadima/Pre-Kadima members must be in their assigned houses at curfew and remain there. Each participant is expected to conduct him/herself appropriately as a Conservative Jew (including through the observance of Shabbat and Kashrut), in accordance with applicable standards of the Law and Standards Committee of the Rabbinical Assembly and/or the local Rabbinical Authority. Youth Advisor in consultation with the Regional Youth Commission, reserves the right to enforce other rules relating to the integrity of the Regional Youth Program and/or the health, safety or welfare of its participants.
